#### CALL TO ORDER

The Commissioners of the City of Worthing met in regular session on Monday, March 11, 2019 at 7:00 P.M. in the Worthing Community Fire Department.

Mayor Bradley Hazuka presided. The following Commissioners were present: Crystal Jacobson, Sheri Lund, John Ganschow and DeniseMoani Nelson. Also in attendance was Deputy Finance Officer Amy Bauer.

### PLEDGE OF ALLEGIANCE

Mayor Hazuka led the meeting in the pledge of allegiance.

# APPROVAL OF AGENDA

Motion by Lund to approve the March 11, 2019 posted agenda. Nelson seconded the motion. Motion carried, all voting aye.

#### OPEN PUBLIC SPEAKING

Casey Ring, Executive Director of the Olde Towne Dinner Theatre, proposed purchasing Lot 8 for \$1000. It is the north section of the lot behind the memorial and between the civic center and the theater. They would pay any rezoning, surveying or other fees that came with dividing the lot. Casey let the Commission know that this proposal was on the agenda for the next planning and zoning meeting, he will contact Jason Schroeder to confirm. The Commission will wait until after the planning and zoning meeting to see if this is an option. The city will look into the procedures to surplus the lot. Lund asked if leasing was an option for them. Casey said they would prefer to buy, but he would talk to his board to see if that would also be an option. They would be looking to build a shed on the lot sometime this summer.

### MAINTENANCE REPORT

Maintenance has been working on snow removal, cleaning the shop and fixing equipment. At this time, they report that all culverts in Worthing are draining. It is important that people do not put their sump pump hoses down the city's sewer system or it will cause major problems with the rain that is forecast. There will be a \$500 fine for any violation.

# FINANCE OFFICER REPORT

Deputy Finance Officer Bauer said that the Bossman and Kibble insurance claims have been submitted. We will know more about the deductibles once the insurance company has looked over the claims. Bauer also reported that a meeting is required on March 18<sup>th</sup> for equalization, even if there are no disputes. The deadline to file a dispute is 5pm on Thursday 3/14.
